# Programme Overview

Expectations for doctors and medical professionals have increased along with the advancements in medicine. The roles of Doctors and other health professionals bounded by the institutional expectations and standard of practice. Medicine should not only be focused on discovering and treating illnesses but also ethical and legal aspects surrounding everyday medical practice.

in Medical Ethics & Law programme incorporates The Master various aspects of learning modes that enable enrolled students to be exposed to multiple issues concerning competency, responsibility, ethical and continuous professional development. This course behaviour was first established in 2014 as the Master of Medical Ethics and Medical Jurisprudence and was the first of its kind to be offered in Malaysia. Its curriculum was reviewed in 2020 and is now offered as the Master in Medical Ethics and Law. This is a 40 credit unit fulltime course offered over 3 semesters.

## Course Details

Candidates will acquire knowledge, mastery of skills, and develop attitudes and behaviour required in this field through the lectures, tutorials, case studies and dissertation, they will also have the opportunity to be involved in local and international medical ethics and law seminars or conferences.

# Application Criteria

## Compulsory Entry Requirements

#### A. Academic Qualification(s)

- i. Undergraduate medical degree from a university recognised by the Senate of Universiti Teknologi MARA (UiTM) with CGPA of ≥2.75, or
- ii. Undergraduate law degree from a university recognised by the Senate of Universiti Teknologi MARA (UiTM) with CGPA of ≥2.75, or
- iii. Undergraduate degree in a relevant health-related field from a university recognised by the Senate of Universiti Teknologi MARA (UiTM) with CGPA of  $\geq 2.75$ , or
- iv. Postgraduate degree in a relevant health related field from a university recognised by the Senate of Universiti Teknologi MARA (UiTM), or
- v. Applicants with a degree from i-iii with a CGPA of <2.75, but possess at least 1-year relevant work experience in medical ethics and/or law, AND are subject to an rigorous internal assessment, or
- vi. Applicants without a qualification/working experience in the related fields, but meet the minimum CGPA based on i-iii, AND pass the prerequisite courses.

#### B. English Language Requirements

- i. International Language English Testing System (IELTS)- an overall band score of not less than 6.0 in academic English, with no band less than 6.0 in each section, or
- ii. Test of English as a Foreign Language (TOEFL)- a score of not less than 550, or
- iii. Malaysian University English Test (MUET)- a score of not less than band 3
- C. Fulfil all other university requirements and regulations





## **Application Criteria**

## Others Entry Requirements

Applicants who fulfil ALL the above requirements will be shortlisted for a selection interview. In assessing applications, the Selection Committee will consider:

- i. Relevant work experience in the field of study, and
- ii. Prior academic performance

Prior to the selection interview, applicants are also REQUIRED to submit the following documents for the Selection Committee's evaluation:

- i. A short essay of 1000-3000 words length in English on any topic relevant to medical ethics and law,
- ii. A personal statement
- iii. A curriculum vitae (CV)
- iv. 2 recommendation letters (using the referee report form)
