General Guidelines of LACU (refer to Standard Operating Procedures (SOP) for A Good Laboratory Animal Practice)

Pre-animal handling

- Follow LACU Standard Operating Procedure (SOP).
- Information regarding the number, type, source and age of rodents/mice/rabbits must be made available to the LACU staffs prior to arrival of rats/mice/rabbits for quarantine
- Rats/mice/rabbits will be guarantined for a period of 1 to 2 weeks.
- -The preferable time to admit rats/mice/rabbits to quarantine would be before 10.00 am or after 5.00 pm.
- It is the responsibility of the researcher to collect the rats/mice/rabbits and transfer them to the respective breeding rooms.

During animal handling

- Follow LACU Standard Operating Procedure (SOP).
- Upon discharge from quarantine, animals must be placed in the Breeding rooms (mice, rat and rabbits) by the researchers. The researcher is henceforth responsible for the animals.
- The researcher should inspect their animals 2 times a day at 8 to 8.30 am and 4.30 to 5 pm.
- Animal drinking bottle should be kept clean at all times. Reversed osmosis water and dry food are used for all the rats/mice/rabbits.
- The animals are to be fed and given water accordingly.
- Bedding must be changed three times a week (Mondays, Wednesdays and Fridays).
- The floor should be kept clean of any feed and bedding spillage.
- Conduct your experiment in an ethical way, any problems regarding the rats/mice/rabbits that you encounter during your research, kindly inform the staffs immediately for further action to be taken if any.

Post animal handling

- Follow LACU Standard Operating Procedure (SOP).
- Places carcasses of sacrificed rats/mice/rabbits in the biological disposal bags, provide the label with date/time/researcher and keep the bags in the animal freezer.
- Clean all the used cages or any used equipment before leaving.
- Inform the staffs upon completion of you research
